# Update from Our Outgoing Councilwoman Ann Margolin

First, since I may not have another chance to write in your newsletter again as a city council member, I want to thank you for giving me the opportunity to serve in this capacity for four years. I have gotten to know the Hockaday



Neighborhood Association and you are a wonderful group of people who care deeply about your neighborhood and your city. It has been a great honor to represent you.

I also thought you might want to know about an upcoming project that will result in great improvements in Dallas traffic but tie us up on knots for 4-5 years. In summer of 2013 TxDOT is ready to start construction on the "Horseshoe" project which will include the IH30 Bridge (the Margaret McDermott Bridge), IH35 Bridge and the mixmaster (the interchange between IH30 and IH35.) The Margaret McDermott Bridge will be a second Calatrava-designed bridge and will include pedestrian and bicycle facilities. All funding has been identified for this \$800 million project, the large majority being federal funding with a small amount of state. private donations (for the Calatrava component) and about \$3million in local funding.

# ONCOR – Our Electric Power Service Provider

Many within HNA have voiced concern regarding perceived frequent power outages and surges in our area. Connie Campbell met with two Oncor supervisors in January, and following is the outcome of that meeting:

- 1. Our Hockaday neighborhood consists of 4 separate electric grids. So the homes within our boundaries will experience different power outages and surges, unless there is a total power outage in the area. At least 2 of the grids divide streets down the middle.
- 2. The Hockaday School is on its own grid.
- 3. The electric lines are the highest lines you see on the utility poles. They run along the top portion of the poles, they are level with the large grey vertical canisters. Those lower lines are telephone and cable. So when our power goes out, look to the top lines to determine if a tree branch is pulling the line and causing outage.
- 4. Inclement weather is the leading cause of power outages: storms, high winds, lightning strikes, ice, extreme heat (summer heat will cause lines to sag, which can cause outage). Car accidents are another cause (car hits utility poles, lines pull, loss of power). Our neighborhood has many mature trees; therefore, we have increased chance for loss of power due to tree branches and squirrels tripping the transformer.
- **5.** Individual homeowners are responsible for keeping the line from the utility pole to their home "free of disturbance" (it is your responsibility to trim those branches that might touch the line spanning from the alley into your home). Oncor's tree trimming contractors are responsible for the limbs from utility pole to utility pole.
- **6.** The majority of our homes were built in the late 50's and early 60's, and many originally had less square footage than they do now. The original power grids were designed to provide electricity to homes of that era and square footage. Now we have many remodels and home additions, some new construction, and LOTS more electronics throughout. Oncor can come to your home (at your request) and perform a voltage study.

- **7.** Oncor performed an overall "capacity study" of our neighborhood, and determined that there is currently ample power being delivered to our homes via the 4 grids.
- **8.** Surge Protectors are important for your televisions, recorders, cable boxes and computers.
- **9.** Use the Oncor website to submit service request orders for tree trimming if you see a potential problem with branches they may have missed. Oncor performed an extensive tree trimming service in our neighborhood this past Fall.
- 10. If you have medical hardships that require electric power (oxygen or CPAP machines), you qualify for special status (Chronic Condition or Critical Care Residential Customer Status) through the Public Utility Commission of Texas. You can access the application via the Oncor website, have your doctor sign the form. Of course, Oncor cannot guarantee that you will never have a power outage, but you will receive special attention if your power will be out for an extended period. ### **HNA Construction Zones**



If you are building or remodeling your home, please note that HNA requires all vehicles associated with a construction project to park on the same side of the street

as the project. This alleviates congestion for traffic flow down the streets and is much safer. Vehicles also should be parked in the correct direction (the City issues tickets for cars parked facing the wrong direction).

### **Resolve Neighbor Squabbles**

Some have contacted HNA officers to request that the Association mediate issues with neighbors, such as barking dogs, heavy trash put out too early, issues with fences or overgrowth of lawns or shrubs, watering lawns on off days, etc. HNA encourages you to work out these issues directly with your neighbor. Usually there will be cooperation. If a problem sadly persists, you may report it to the City through its website, dallascityhall.com; click the tab "311 Info & Services."

## Neighborhood Baby, Kid, Pet and House Sitters Available




HNA keeps a list of neighborhood young people (and adults) who are available for baby/child sitting, house checking, pet care, errands and other
